



## SPECIFICATIONS

The Technologic Pump Logic Controller, Adjustable Frequency Drive(s) and Bypass circuitry (optional) shall be mounted on a single door, NEMA-1 enclosure and be prewired at the factory to permit a single electrical power connection. A disconnect switch shall be provided for each AFD. The entire assembly shall be ETL listed. The enclosure shall be designed to be wall mounted. All functions of the components shall be tested and approved at the factory prior to shipment. Input power wiring and wiring from the cabinet to the motors shall be provided by the electrical contractor. Wiring from sensors to the cabinet shall be provided by the controls contractor.
